Texas Administrative Code

To become licensed, engineers must complete a four-year college degree, work under a Professional Engineer for at least four years, pass two intensive competency exams and earn a license from their state's licensure board. Then, to retain their licenses, PEs must continually maintain and improve their skills throughout their careers.

The Board regulates the practices of engineering and land surveying in the state of California by evaluating the experience and administering examinations to prospective licensees and by enforcing the laws regulating licensed professional engineers and land surveyors. Board for Professional Engineers, Land Surveyors, and ...

A registered firm must have at least one actively licensed PE that can perform engineering duties. If you are an engineer of record for a firm (a PE listed on the firm's registration) and you become inactive, you may effect the registration of the firm if there are no other active licensed PE's.

Effective September 1, 2019, HB1523 creates the Texas Board of Professional Engineers and Land Surveyors (TBPELS). Work on the merger of the engineering and surveying boards is well underway. All land surveyor functions will be moving to the new location at TBPELS the first week of September. September 2nd we will be closed for Labor Day.
